Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security Number and Credit Scores • Income and Account Balances • Employment Information and Mortgage Rate and Payments 	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Heritage Funding chooses to share; and whether you can limit this sharing.

What happens when I limit sharing or an account I hold jointly with someone?	Your selections apply to everyone on your account, unless you tell us otherwise.
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Heritage Funding does not share with our affiliates.</p>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Nonaffiliates we share with can include Lenders to whom we submit mortgage applications, and contact relationship managers or other service providers who distribute informational or promotional materials on our behalf.</p>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>Heritage Funding does not share with non-affiliates for the purpose of joint marketing.</p>
